om Lentz of Sheboygan Falls received the award of Master Naturalist of the Year. The Wisconsin Master Naturalist Program is a statewide network of well-informed citizens dedicated to conservation education and service within Wisconsin communities. Most states across the country offer similar master naturalist programs to increase informed volunteer service related to natural resources.

Tom Lentz truly is an outstanding Master Naturalist and amazing volunteer for so many different organizations! Congratulations to Tom on receiving the Master Naturalist of the Year

For many years Tom participated in the Sheboygan County 4-H program and attended numerous programs at the Kettle Moraine State Forest – Northern Unit with his daughter, April. As time progressed, Tom started to volunteer in leadership roles for both organizations and conducting numerous nature-based activities and programs.

In the fall of 2013, Tom took part in the 40-hour Master Naturalist training at Riveredge Nature Center located near Newburg and became one of the first Master Naturalists in the state. To continue as a Master Naturalist, Tom must complete eight hours of continuing training and 40 hours of services in the areas in natural resource education, stewardship, and/or citizenscience projects.

Since becoming a Master Naturalist in late 2013, Tom has logged more than 500 hours of volunteer time. He conducts and assists with a wide variety of programs at the Kettle Moraine State Forest – Northern Unit including Nature Sensations, Saturday Morning Nature Explorers, and the Halloween Nature Hikes. With the 4-H, he coordinates special nature-based programs and participates with many of their special events. To top things off, he shares his knowledge, talents, and time with the members of his church
