### GENERAL RULES:

- \* Negative Coggins required within the year. All entries must present an original coggins on the day of show along with a copy that will be kept by the office.
- \* A horse may enter more than one halter class.
- \* Riders/handlers must be in 3rd grade as of January 1st of the current year.
- \* All riders are required to wear equine(SEI) helmets, with harness fastened when mounted.
- \* Please treat animals humanely and with dignity, and compassion. Mistreatment will be dealt with.
- \* Riders in classes marked RESTRICTED walk/trot may ONLY enter walk/trot classes. Registered 4-H HHG members may enter RESTRICTED walk/trot classes. You may enter any halter and showmanship classes.
- \* Horseless Horse Groom (HHG) classes are open ONLY to registered 4-H HHG members, regardless of age. HHG members may only enter walk/trot classes.
- \* Stallions must be handled by exhibitors 19 years and older as of January 1st of the current year.
- \* Please use the assigned numbers given with your entry.
- \* The Tissadi Versatility Class is open to Sheboygan County 4-H youth only. Please see handbook for specific rules.
- \* High-point awards presented in each category for rider/horse combination accumulating most points. \$2.00 per high point. Sign up by 10AM on the day of the show. Ineligible high point classes are designated with an asterisk\*.
