The first place to start is with a thorough review of the materials that are available in this Extension Program Policy and Approval Forms & Resources for 4-H Leaders Drive. This includes the proposal for all Extension programming as well as the materials that leaders need to post, publish and follow before, during and after the program.

After watching the video, complete this short quiz/form to confirm your participation. This will serve as an official record of volunteers who completed a "safety training."

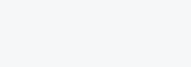
