Campus/Office Update

An Update from UW Green Bay, Sheboygan Campus and our Extension office.

Campus is going to remain in the same mode they have been since July 1st; open only to staff and faculty and individual students, members, and volunteers by appointment.

Starting on Aug. 24th, will resume campus hours of 7am-10pm M-Th and 7am - 5pm on Fridays. Weekends will be closed as we were prior to COVID-19.

Campus will not be open to the "general public" (those not enrolled in any type of class or not having an appointment with a staff member) until after Jan. 1, 2021. This decision is being reviewed on Oct. 1, 2020.

UWGB is assessing classroom capacities based on having a 6ft distance from any students while they seated. For most classrooms, this equates to a capacity of about 20% of pre-COVID levels.

Masks will be required for anyone that is on campus.

The Extension Drop-box is checked several times each week and is still a good method to deliver paperwork and other information to staff.

What does this mean for our Extension office? When/if we get the green light to go back to the office, we will only be able to meet one on one with volunteers or visitors and they will need to have appointments. There will not be any group meetings held on campus through the rest of 2020 unless something changes.
