^{*}All Riders are required to wear equine (SEI) helmets, with chin strap fastened when mounted.

^{*}Horseless Horse Groom (HHG) classes are open ONLY to registered 4-H HHG members, regardless of age. HHG members may only enter walk/trot classes.

^{*}Stallions must be handled by exhibitors 19 years and older as of the current year.

^{*}All dogs on the grounds must be on a leash. Dogs may be asked to be removed from grounds for excessive barking.
