Letter Describing Extension Nondiscrimination Policies

Dear Sheboygan County 4-H Families,

Periodically, Division of Extension takes steps to assure that our partners know and understand our policy of nondiscrimination. This letter is to remind or notify you that the Division of Extension does not discriminate in the treatment of individuals, in the admission or access to its programs and activities, in the provision of services, or in employment.

Further, Division of Extension will not participate with organizations or in activities which discriminate on the basis of any of the legally prohibited categories of discrimination. Categories of prohibited discrimination include race, color, gender/sex, creed, disability, religion, national origin, ancestry, age, sexual orientation, pregnancy, marital or parental status, arrest or conviction record, or membership in the national guard, state defense force or any other reserve component of the military service.

The Sheboygan County Alumni Association has grant money available to 4-H members for out of county events & trips (example 4-H camp.) The due date for the application was April 1st but because of COVID-19 impact we have extended the dead line for the application to May 1st.

There are many updates regarding holding programs and meetings face to face. I am going to summarize them here and if you have any questions you should call me at 920-459-5915 so that I can clear things up right away - please do not let your questions linger when I can help!

- Written Program Proposals/Checklists/Approval is NO LONGER NEEDED!!!!!! YAY!!!
- > Contact logs for participants must still be kept at your club or project level in case we need to follow up with participants. You DO NOT turn these into me any longer!

April 1-June 1, 2021 Extension Program Policies:

Indoor Programs:

- limited to 4 hours
- limited to 30% capacity of a room or 50 people (whichever is fewer)
- Use pods of 20 people whenever it makes sense to do so; individuals not to circulate between pods but a facilitator can
- maintain a social distance of 6 ft
- face masks are required indoors
- communicate plans for pick-up drop off, avoiding congregating is spaces
- provide hand sanitizing and hygiene materials
- Keep all food outdoors

Outdoor Programs:

- No time limit
- limited to 150 people
- maintain a social distance of 6 ft or more
- use pods of 20 when it makes sense to do so; individuals not to circulate between pods but a facilitator can
- face masks required only when social distancing is challenging
- communicate plans to pick-up, drop off, avoiding congregating in spaces,
- provide hand sanitizing and hygiene materials

June 1, 2021, through "Summer" Policies:

- Continue using face coverings
- Continue physical distancing six feet apart
- Indoor events are at 50% of room capacity up to 350 people
- Outdoor events may have up to 500 people.
- Podding is no longer required. However, the Center for Disease Control suggests using pods for day-long programs.
- Time limits for indoor and outdoor programming have been removed
- Food is allowed at events longer than two hours as long as CDC school lunchroom guidance is followed for physical distancing, minimizing time with masks removed, and washing or sanitizing hands
- Contact your county educator for food stand fundraisers or foods and nutrition programming guidance
- Reminder, always follow County Health Department guidelines if stricter than the above guidelines
- Continue working with your county 4-H staff to plan summer programs

These opportunities do not need to be a big deal - but should include something hands-on for the kids to create and an opportunity for the kids and parents to get to



Volunteer Development and Management

In the Sheboygan County 4-H Program, **volunteer management and development** is a priority! With 226 Certified 4-H Volunteer Leaders, it is critical that staff engage volunteers in ongoing educational processes designed to build capacities for their service roles. By actively engaging volunteers and organizing volunteer efforts, we are able to provide hundreds of opportunities throughout the year for over 1,500 youth, K-13th grade.

In order to manage and develop volunteers effectively, staff hold group trainings throughout the year and are available for one-on-one consultations and support. Trainings include research based information on positive youth development, conflict management and problem solving, risk management, and financial management. Along with ongoing volunteer development and management, a required 4-H Volunteer Orientation is held for new volunteers. This year, 36 adults were certified through our Sheboygan County **4-H Volunteer Youth Protection Program**. The primary purpose of this process is to ensure the safety and well-being of all participants (i.e., youth, their parents and families, salaried and volunteer staff.)

The Value of Volunteers

As volunteers offer their time, talents, and/or resources to 4-H Youth Development Educational Programs, they do so without monetary expectation and yet give generously and graciously. During the 2020 4-H Youth Development Program year, approximately 7,402 hours (roughly 33 hours per year per volunteer with 226 volunteers) of 4-H Volunteer service hours were contributed to the Sheboygan County 4-H Program for a dollar value of \$211,253.058.

This spirit of volunteerism isn't limited to the adults in our program. The 4-H Study of Positive Youth Development, a longitudinal study that began in 2002 and has been repeated over eight years with the Tufts University research team indicated that 4-H'ers in grades 7-12 are nearly four times more likely to be actively engaged in their communities than their peers. In fact, one of the essential elements of positive youth development involves Generosity. Young people need to have the opportunity to discover who they are by gaining exposure to the larger community and the world. 4-H engages youth in this opportunity through service to others—our 4-H clubs have served over 148 different organizations through their service in the last year alone.
