Extension COVID-19 Policy Updates

There are many updates regarding holding programs and meetings face to face. I am going to summarize them here and if you have any questions you should call me at 920-459-5915 so that I can clear things up right away - please do not let your questions linger when I can help!



UW-MADISON EXTENSION

- > Written Program Proposals/Checklists/Approval is NO LONGER NEEDED!!!!!! YAY!!!
- Contact logs for participants must still be kept at your club or project level in case we need to follow up with participants. You DO NOT turn these into me any longer!

April 1-June 1, 2021 Extension Program Policies:

Indoor Programs:

- limited to 4 hours
- limited to 30% capacity of a room or 50 people (whichever is fewer)
- Use pods of 20 people whenever it makes sense to do so; individuals not to circulate between pods but a facilitator can
- maintain a social distance of 6 ft
- face masks are required indoors
- communicate plans for pick-up drop off, avoiding congregating is spaces
- provide hand sanitizing and hygiene materials
- Keep all food outdoors

June 1, 2021, through "Summer" Policies:

- Continue using face coverings
- Continue physical distancing six feet apart
- Indoor events are at 50% of room capacity up to 350 people
- Outdoor events may have up to 500 people.
- Podding is no longer required. However, the Center for Disease Control suggests using pods for day-long programs.
- Time limits for indoor and outdoor programming have been removed
- Food is allowed at events longer than two hours as long as CDC school lunchroom guidance is followed for physical distancing, minimizing time with masks removed, and washing or sanitizing hands
- Contact your county educator for food stand fundraisers or foods and nutrition programming guidance
- Reminder, always follow County Health Department guidelines if stricter than the above guidelines
- Continue working with your county 4-H staff to plan summer programs

The necessary forms for our program this year are attached. The Waiver/Code of Conduct form must be printed, signed by parents and members (2 places) and returned to us via email at Sheboygan4hArchery@gmail.com BY MAY 7, 2021.

The fee of \$7.00 per member PER SHOOTING DISCIPLINE will also be collected along with the completed Receipt the first time the member participates. IF THE MEMBER IS ENROLLED IN ARCHERY AND AIR RIFLE, SEPARATE COPIES OF THE WAIVER AND CODE OF CONDUCT FORM NEED TO BE COMPLETED FOR EACH DISCIPLINE. One receipt per family is needed. Please complete both the top and bottom with the same information. We will keep the top and you will receive the bottom when the fees are paid. If you are paying with cash, please bring the exact change. Thank you.

State guidelines no longer require medical information. Therefore, it is your responsibility to voluntarily inform us of any medical information that we would need to know while the members are with us. This especially refers to any conditions that could become life-threatening.

We will again be holding our shoots at the Sheboygan County Fairgrounds in Plymouth. You will receive notifications by email from <u>sheboygan4harchery@gmail.com</u>. A test email should be coming through by May 12, 2021. If you do not receive a test email, please send a message to be sure you are on our email list. The shooting schedule and sign-up will be handled through email. Shooting dates will be shared at the May 4th meeting.

ATTENTION PARENTS: We are always in need of more state-certified adult leaders, especially in Air Rifle. There are no training dates scheduled at this time.
