

Household and Farm Hazardous Waste Clean Sweep Sheboygan County Farms & Households

The following charges apply to help cover the cost of the program.

- \$15 per Vehicle charge with only hazardous waste.
- \$40 per Vehicle charge (6 items or less) with electronics only. More than 6 electronic items will generate additional fees.
- \$40 per Vehicle with both hazardous waste and electronics

How do I know what materials are hazardous?

Products that are out-ofdate, unused, damaged or banned have the potential to be hazardous. These items maybe found in old farm buildings, basements, garages, under the

kitchen sink, in craft areas and workshops. Look for key words on the label like: *danger*, *warning*, *caution*, *poison*, *combustible*, *and toxic*.

Program Participation Guidelines

This program is available to households, farms, agri-businesses, and qualifying small businesses throughout Sheboygan County.

The fee schedule for 2021:

- \$15 Vehicles with only hazardous waste.
- \$40 Vehicles with household size (6 items or less) electronics only. More than 6 electronic items will generate additional fees.
- \$40 Vehicles with both hazardous waste and household size electronics.

Wastes must be brought in the original containers if possible. Keep materials separate. Do **NOT** mix chemicals. To prepare materials for transport, line a cardboard box with a plastic bag. Place them in a box and separate with cardboard.

Acceptable Materials

Plant, Pest, Yard and Lawn Care Chemicals
 Pesticides, herbicides, fertilizers, insecticides, fungicides, rodenticides, and other poisonous repellents and banned chemicals.

Acceptable Materials continued ...

 Oil-Based Paints, Solvents, Cleaners, and Related Products

Varnishes, shellacs, turpentine and thinners, lead and oil-based paints, aerosol paints, wood preservatives, arts and crafts paints, stripping, preservative chemicals, reactives, oven cleaners, spot removers, polishes, pool and spa chemicals, moth balls, and cleaners. **No latex paint.**

• Farm Machinery and Vehicle Products

Contaminated oil, hydraulic oil, antifreeze, old gasoline, and farm oil filters.

Miscellaneous

Household quantity fluorescent bulbs, household batteries, bulk mercury, mercury containing devices such as thermometers and thermostats, household bulbs, acids and bases.

Electronics Accepted

Monitors, Desktops, Laptops, Keyboards, Mice, Printers, Scanners, Fax Machines, TV's, VCR's, Phones, Typewriters, Calculators, Stereo Equipment, & many more.

Unacceptable Materials

The following items **cannot** be accepted. Please contact your local unit of government.

 Latex Paint, Waste Oil, Radioactive Material, Explosives, Medical Wastes, Pressurized Cylinders, Large Appliances and tires.

What about latex paint?

Latex paint is not a hazardous waste. Remove the lid and let it dry or mix with kitty litter. Once hardened, latex paint can be disposed of in the trash.



Agricultural Hazardous Waste

Agricultural Hazardous Waste include pesticides, other chemicals, and pesticide containers. For larger quantities (greater than 250 pounds), please call Mike Ballweg, Extension Sheboygan County, at (920) 207-0397 in advance. There may be a cost for Agricultural business wastes.

Hazardous Waste from Small Businesses

Very Small Quantity Generator Businesses must call Veolia North America to pre-register **1 week** prior to the collection date. Contact Chris Bahlow at (715) 298-2623 for a registration form. There will be a cost for disposing of these items.

Waste Pharmaceuticals

Waste Pharmaceuticals can be recycled in the lobbies of the Sheboygan, Kohler, Sheboygan Falls, Plymouth, and Elkhart Lake Police Departments. Each department has an anonymous drop box for recycling.
