### **REQUIREMENTS AND RULES FOR USE OF MANAGERIAL GOATS**

- A managerial goat is defined as any goat that is not owned by the 4-H member or his/her immediate family (parents, siblings, grandparents or guardian). Please contact a Sheboygan County 4-H Goat Project Leader to discuss your current situation if you have any questions.
- The objective of the Goat Managerial Project is to allow a 4-H member that does not own a goat to have the opportunity to learn the skills of feeding, caring for and training of goats. Through the experience they learn the skills of decision making, information gathering, communication, responsibility and self-confidence.
- A secondary objective is to allow current goat project members the opportunity to experiment with a breed(s) that they do not already own. They may NOT take on a Goat Managerial Project within the breed(s) they currently own.
- Managerial goat(s) will be housed at the owner's location unless agreed upon by all parties.
- Up to 4 managerial goats are allowed at the discretion of the owner and the 4-H member. Up to 4 managerial goats are allowed to show at the Sheboygan County Fair pending adequate space is available in the barns. Numbers may be reduced if necessary.
- This Goat Managerial Project begins the date the agreement is signed and ends at the completion of the project year (end of the Sheboygan County Fair). The 4-H member and goat owner may choose to renew the contract for another year.

**MEMBER:**

- I agree to the rules and policies set forth in the Sheboygan County 4-H Goat Project. I have read and understand this Goat Managerial Contract and will abide by it.
- I agree to spend at least 20 hours of time with the managerial goat(s) from the start of the contract date through the start of the County Fair. Activities include, but are not limited to cleaning pens, feeding, watering, milking, fitting and training.
- I agree to keep a Goat Managerial Project Record to document the time spent and specific activities performed caring for and working with the managerial animals.
- I agree to provide all materials needed while the managerial goat(s) are at the fair not limited to bedding, water and feed.
